The EADA Report

The Equity in Athletics Disclosure Act (EADA) requires a school that has an intercollegiate athletic program to make prospective students aware of its commitment to providing equitable athletic opportunities for its male and female students. As part of this requirement, each fall schools must make certain information available to students, prospective students, and the public in easily accessible places and must also report the information to the Department.

**I. Documentation as it relates for the EADA for 2020-21 fiscal year.**

- Number of male and female full-time undergraduate students that attended the school (undergraduate students are those who are consistently designated as such by the school)

Response: Los Angeles Trade-Technical College has men and women's basketball. There were 13 men and 11 women student-athletes.

- Total amount and ratio of athletically related student aid awarded to male athletes compared to female athletes.

Response: Student Aid awarded to male-athletes compared to female athletes is zero. If a student-athlete is eligible for Federal Student Aid, this is the only federal assistance that is provided and not by the campus, but through the Federal Student/Financial Aid application process.

- The expenses incurred by the school during fiscal year (July 1, 2020 to June 30, 2021) for men's and women's sports. Total annual revenues for men or women's sports.

Response: Total annual expenses (defined as budgeted amount minus end-balance revenues)

1. Men - \$131,871
2. Women - \$24,600

Response: Total annual revenues (defined as budgeted amount minus expenses) for men and women for fiscal year 20-21 were as follows:

1. Men - \$139,268, 2. Women - \$298,206

**Please note: Due to COVID-19, LATTC didn't participate in intercollegiate sports activities last year due to health and safety protocols within the County of Los Angeles.**

- Annual school salary of non-volunteer head coaches and assistant coaches for men's and women's teams.

Response: Head coach salary for just primary coaching is \$21,088 per sport. LATTC has two sports, men and women's basketball. The head coach salary doesn't include the teaching of pre-conditioning or in-season credit classes as part of the stipend. Teaching assignments are paid separately from the stipend. We have one head coach who coaches both the men and women's teams.

Assistant coaches: LATTC has a total of four (4) assistant coaches, two for men's basketball and two for women. Their salary is \$14,000 per assistant coach.

- Number of each varsity team in intercollegiate competition, the number and gender of participants and coaches, operating expenses, etc.

Response: For the men's team, there were 13 student-athletes and for the women, there were 11 student-athletes. Please note: **LATTC didn't play any intercollegiate sports game due to COVID-19 health and safety concerns.** In a regular season, there would be one (1) head coach, two (2) assistant coaches for the men, and two (2) assistant coaches for the women. For the women, there is one (1) female assistant coach and one (1) male assistant coach.

- Total operating expenses for Fall 2020:

Response:

1. Men's basketball and administrative operations. Total budget: \$271,139 and expenses were \$131,871.
2. Women's basketball and administrative operations. Total budget: \$322,806 and expenses were \$24,600.

**Please note: For Fall 2020, most of the expense were permanent salary and benefits.**

**PLEASE NOTE:**

Los Angeles Trade-Technical College (LATTC) did not hold any intercollegiate sports activities (NO competitive sports activities) during the fiscal year of July 1, 2020 through June 30, 2021). Even though the college decided to "opt-out" of competitions during this period, there were still program expenses that needed to be paid.

- Expenses that were not directly tied to teams holding competitions during the July 1, 2020 to June 30, 2021 reporting year

Response: Personnel cost pertaining to full-time salaries, part-time (remote) teaching of basketball skills courses for both men and women, needed equipment for remote working, recruitment of student athletes and employee benefits were paid as part of the administrative, full-time employee obligations of the college.

- Total amount of money spent on athletically related student aid, including the value of waivers of educational expenses, separately for men's and women's teams overall.

Responses: Men: None. Women: None

- The ratio of athletically related student aid awarded male athletes to athletically related student aid awarded female athletes.

Response: No athletically related student aid awarded male or female student-athletes.

- The total amount of expenditures on recruiting, separately for men's and women's teams overall.

Response: As part of the Head Basketball coach's stipend during the Summer for recruitment of student-athletes, a stipend is paid once the regular season starts. LATTC has men and women's basketball as its only two sports. The Head Coach, given that there are two teams in one sport, and the practices do not overlap, two total stipend – one for the men's team and one for the women's team are paid to the Head Basketball coach.
